
Section 3. Each full time police officer shall be compensated for their time required in Municipal Court, Juvenile Court, County Superior Court, Federal Court or Motor Vehicle Court in Trenton, when the officer is off duty at the rate of \$120.00 per court session.

Section 4. Repealer All Ordinances or parts of Ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflict.

Section 5. Severability If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The Mayor and Borough Council of the Borough of Chesilhurst declare that they would have passed the Ordinance and each section and subsection thereof, irrespective of the fact that any one or more subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.


Section 6 Effective Date: This Ordinance shall take effect immediately upon passage and publication according to law and Retroactive to January 1, 2018.
