This is my report for September 2021.

Board of Health


- NJ introduced a COVID vaccine card app called Docket. This app is useful in case your ID card is lost or destroyed. Prior to the implementation of this app there was a long process to obtain a new card. Now you can keep your ID card on your phone. Right now it only gives New Jersey residents information about the COVID test they received in New Jersey however they are working on a way to retrieve information about residents who received their shot out of state and a way to house all of your vaccinations there.
- Governor Murphy signed an executive order instituting vaccination or testing requirement for all Preschool to Grade 12 Personnel. He is also providing the funding needed for Staff screening and testing at K-12 schools
 - o In addition, the Governor is strongly advising everyone to wear masks in crowded indoor settings and where you may be in contact with unvaccinated people. This is important to remember as we approach the Labor Day weekend.

Emergency Management

- I have not met with the other member of the team as this is a new appointment however there are steps our residents can take to prepare themselves and their households in case there is a public emergency.

- August 31st was International Overdose Awareness Day. Chesilhurst did not host one this year. The closest ones were in Bridgeton and Millville There were only 15 in the State of NJ. This is a day where there is an observance to remember loved ones that have been lost to overdose. There can be a candlelight vigil or butterfly release but the last one we had there was a balloon release after the names of loved ones were spoken.

There are plans in the works to plan an event during Hispanic Heritage month which runs from September 15th through October 15th is less than 2 weeks away. Right now there plans to have an event on October 2nd where Hispanic residents will be able to reflect and share with the community the contributions Hispanics have made.

Economic Development

BOARD OF EDUCATION REPORT

The Governor has mandated that all Pre-K through 12th grade personnel must be fully vaccinated by October 18th. Those unvaccinated personnel would be tested once to twice weekly.

The reopening of The Winslow Township and Waterford Township Schools will begin on September 7th. All students and teachers are required to wear masks when entering the school building. All students are required to wear mask while on the bus. Bus windows will be opened to allow ventilation when necessary. Buses will be cleaned daily between routes.

While in the classroom, desks and furniture will be adjusted to accommodate social distancing. Cafeteria social distancing will be accomplished by adding additional lunch periods, when and if necessary.

Winslow Township School Back to School Night is Tuesday, September 14th from 6:30-8:00 pm.

Our Police Department along with the Camden County Office of the Sheriff will sponsor a **Back to School Supply Giveaway on September 18th from 10am-3pm at the Shirley B. Foster School**.
