

CHESILHURST BOARD OF HEALTH ORDINANCE 2023- 3 BOH

**AN ORDINANCE BY THE CHESILHURST BOARD OF HEALTH TO ADOPT NEW
"REVISED GENERAL ORDINANCES OF THE BOARD OF HEALTH OF
CHESILHURST, NEW JERSEY, 2023"**

WHEREAS, the Borough of Chesilhurst wishes to memorialize and affirm its creation and administration of its local board of health; and

WHEREAS, the Chesilhurst Board of Health has prepared a revised and amended Board of Health Code entitled "**General Ordinances of the Board of Health of Chesilhurst, New Jersey, 2023**" a copy of which is annexed hereto as **Exhibit A**; and

WHEREAS, the aforesaid Chesilhurst Board of Health Code incorporates by reference the following New Jersey State Codes:

- *Sanitation in Retail Food Establishments and Food and Beverage Vending Machines, N.J.A.C. 8:24-1 et seq.* (New Jersey State Sanitary Code).
- *Standards for Individual Subsurface Sewage Disposal Systems, N.J.A.C. 7:9A-1.1 et seq.*
- *Quarantine and Isolation - Model Rules for Local Boards of Health, N.J.A.C. 8:57-1, Appx. B.*

NOW THEREFORE BE IT ORDAINED by the Chesilhurst Board of Health as follows:

Section 1. The "**Revised General Ordinances of the Board of Health of Chesilhurst, New Jersey, 2023**" annexed hereto as Exhibit A and made a part hereof and incorporating by reference the State Codes set forth in the annexed Exhibits B, C and D is hereby adopted to confirm the jurisdiction of the Chesilhurst Board of Health in all public health matters within the Borough of Chesilhurst including all public health services, to set forth requirements and prohibitions and to provide information in connection with those matters and services.


Section 2. If any section, subsection, sentence, clause, phrase or portion of this Ordinance or the Code adopted hereby is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the

validity of the remaining portion thereof.

Section 3. This Ordinance shall take effect immediately upon its passage and publication, or as otherwise provided by law.

NOTICE IS HEREBY GIVEN that the foregoing ordinance was introduced and passed on first reading a regular meeting of the Borough council of the Borough of Chesilhurst, 201 Grant Avenue, Chesilhurst, in the County of Camden, State of New Jersey held on the 2nd day of March, 2023 and will be considered for second reading and final passage at the regular meeting of said Governing Body to be held on the 6th day of April , 2023 at 7:00 p.m. or as soon thereafter as this matter can be reached, at the meeting room of the Borough Hall. All persons interested shall be given an opportunity to be heard concerning this ordinance.

Prior to second reading, a copy of this Ordinance shall be posted in the Borough Hall and copies shall be made available at the Borough Clerk's office at Borough Hall to members of the general public who may request such copies.
