#### ORDINANCE NO. 2023-8

ORDINANCE AMENDING ORDINANCE 2022-6 OF THE BOROUGH OF CHESILHURST, COUNTY OF CAMDEN, NEW JERSEY

WHEREAS, the Borough of Chesilhurst, County of Camden, New Jersey ("Borough") has heretofore duly and finally adopted Bond Ordinance 2022-6, authorizing the completion of acquisition of various public works vehicles and equipment for the Borough ("Bond Ordinance"); and

WHEREAS, the Borough is desirous of amending the Bond Ordinance to reallocate certain unused and unexpended amounts provided for in Section 7(A) of the Bond Ordinance to provide for the costs of the acquisition of a pickup /sports utility vehicle for the police department as a new purpose listed as 7(B) and to amend the average useful life accordingly.

**NOW, THEREFORE, BE IT ORDAINED**, by the Borough Council of the Borough of Chesilhurst, County of Camden, New Jersey (not less than two-thirds of all the members thereof affirmatively concurring), pursuant to the provisions of the Local Bond Law, Chapter 169 of the Laws of 1960 of the State of New Jersey, as amended and supplemented ("Local Bond Law"), as follows:

**Section 1.** Section 7 of the Bond Ordinance is hereby amended to provide as follows:

<u>Section 2</u>. The average period of useful life of the Bond Ordinance is hereby amended and stated as follows:

- "Section 17. The average period of useful life of the several purposes for the financing of which this Bond Ordinance authorized the issuance of bonds or bond anticipation notes, taking into consideration respective amounts of bond or bond anticipation notes authorized for said several purposes, is not less than 14.34 years."
- Section 2. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the regulations promulgated by the Local Finance Board showing full detail the amended capital budget and capital improvement program as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, are on file with the Clerk and available for public inspection.
- Section 3. All other parts of the Bond Ordinance not amended hereby shall remain in full force and effect.
- Section 4. In accordance with the Local Bond Law, this ordinance shall take effect twenty (20) days after the first publication thereof after final passage.
